**3. EXECUTIVE SESSION** - The Board may vote to go into executive session for consultation with the attorneys for the Town of Clarkdale Personnel Board pursuant to A.R.S. Section 38-431.03.A.3 for legal advice regarding the appeal by Police Officer Robert Church dated February 18, 2013 regarding probation and the handling of both appeals from Police Officer Robert Church (two day suspension and probation) and to instruct its attorneys regarding the appeals pursuant to Section 38-431.03.A.4. The Executive Session will be held immediately after the vote to go into executive session and will not be open to the public. Upon completion of Executive Session, the Board may resume the meeting, open to the public, to address the remaining items on the agenda.
