Clarkdale — August 1, 2007 — The Town Council is seeking applications for appointments to the following town Boards and Commissions. Clarkdale residents interested in serving on any of the following Boards should submit an application to Town Hall no later than August 16th. Most the appointments are two year terms ending September 30, 2009, however, some terms are to fill a vacancy of a term expiring in one year, September 30, 2008. Review the Board and Commission descriptions below, fill out your application and get it to the Town Clerk by August 16, 2007.

The **Board of Adjustment** has two openings. They meet on the fourth Wednesday of each month at 6:00 PM. The board is a quasi judicial body which has powers and duties prescribed by law and ordinance including: 1) To hear and decide appeals to administrative decisions; 2) To interpret the boundaries of zoning districts; 3) To hear and decide variances; 4) To permit the extension of nonconforming uses.

The **Design Review Board** has four openings. They meet on the second Wednesday of each month at 6:00 PM. The board reviews the exterior of proposed new buildings, and proposed alteration to buildings. Also reviewing major development or redevelopments to assure they are compatible with the surrounding environment, preserving and protecting the integrity of the Town.

The **Heritage Conservancy Board** has four openings. They meet on the third Wednesday of the month at 4:00 PM. This board advises the Council and staff regarding the preservation, conservation, and promotion of natural, cultural and historical resources.

The **Library Advisory Board** has four openings. They meet on the first Thursday of each month at 9:00 AM. In addition to the meetings, members participate in two fundraising events for the Library. Fourth of July ice cream social and December's book sale.

The **Parks and Recreation Commission** has three openings. They meet on the first Monday of the month at 5:30 PM. The commission is an advisory body to the Council on park development. Members also participate in the Fourth of July, Halloween and Christmas events.

The **Planning Commission** has three openings. They meet on the third Monday of each month at 6:00 PM. The commission reviews all long-term plans for the Town, including the General Plan, specific plans and rezoning. It also reviews developments and application for preliminary plats.
